WORK COMPLETED DURING REPORTING PERIOD

- Down-To-Earth, LLC (DTE) attended DEP open meetings regarding neighborhood Remedial Action Plan on 11 and 12 October 2007.
- DTE attended NAC meeting on 18 October 2007.
- DTE attended Town of Hamden design Charrette meeting on 25 October 2007.
- On 31 October 2007, Haley & Aldrich and DTE attended a meeting to discuss reuse options for the former Hamden Middle School, Rochford Field, and Mill Rock Park. Also discussed was how remedial concerns could impact design.


The next scheduled quarterly Progress Report will be due on 31 March 2008.


