Ladies and Gentlemen:

On behalf of the Town of Hamden, Haley & Aldrich, Inc. (Haley & Aldrich) is pleased to submit this quarterly Progress Report (No. 3) describing the actions the Town of Hamden has taken to date to comply with relevant requirements outlined in Connecticut Department of Environmental Protection (CTDEP) Consent Order No. SRD-128, Section B (5). Progress Report No. 3 covers the timeframe from 1 October 2003 through 31 December 2003.

**WORK COMPLETED DURING REPORTING PERIOD**

- On 27 and 28 October 2003, Haley & Aldrich conducted a fourth round of groundwater sampling of seven wells located at Rochford Field and Mill Rock Park.

**WORK ON HOLD**

- Supplemental Environmental Investigation Work Plan, Rochford Field and Mill Rock Park.

During December 2002, Haley & Aldrich submitted environmental test results for Rochford Field and Mill Rock Park to CTDEP for review and comment. CTDEP staff has indicated to Haley & Aldrich that the Supplemental Investigation Work Plan for Rochford Field and Mill Rock Park will not be reviewed by CTDEP, until CTDEP has reviewed and commented on previous site work. To date we have received no comment from CTDEP on our December 2002 report.

The next scheduled progress report will be due on 31 March 2003.
