Program Description:

The On-Site Renewable Distributed Generation Program is a \$21 million flexible, integrated-technology financial support program designed to stimulate demand for behind-the-meter installations of renewable energy at commercial, industrial and institutional (CI&I) buildings in Connecticut.

Increasing energy costs in Connecticut has created a growing awareness by CI&I energy consumers of the opportunity for clean customer sited distributed generation. Through the program, the Connecticut Clean Energy Fund (CCEF) will offer financial support to buy down the cost of renewable energy generating equipment and low-interest construction financing. The level of support for individual awards will vary based on the specific economics of the installation. The total available grant amount for a given project will be limited to \$2 MM. A 1¢/kWh premium will be available for projects in southwestern Connecticut.

Connecticut CI&I electric ratepayers may be eligible for this program, if they:

- Desire the installation of a qualified¹, commercially available renewable energy generation device larger than 10 kW at their Connecticut site
- Are the owner and operator of the facility or a third party energy services provider
- Are located within the Connecticut Light and Power (CL&P) or United Illuminating (UI) service territories
- Propose to generate energy for the host site

Interested parties should review the formal solicitation, available on the CCEF Web site www.ctcleanenergy.com, which provides specific program details and procedures for application. Applications for this program are accepted on an ongoing basis.

Once an application is submitted, parties will advance through the following steps:

1. CCEF evaluation, due diligence and modeling
2. Determination and notification of financial support level
3. Applicant decision to proceed
4. CCEF Board approval

Host sites that wish to receive indication of the approximate subsidy amount in advance of an application can submit a letter of interest on the project.

Capital Grants for Customer-Side Distributed Generation Resources

Agency:Department of Public Utility Control (DPUC)

Program Description:

Grants are available for companies that install and operate customer-side generation projects (generators or electric power sources) that reduce load on the electric system.

Funding is available to offset capital costs and is tied to the amount of kW's of load that the facility removes from the system.

Applicants must install and demonstrate successful operation of a customer-side generation facility and enroll in an ISO-NE load reduction program.

An application is available on the DPUC web site.

Contact your electric distribution company for guidance and fill out the DPUC's application form.

Application approval notice is usually within 60 days of the application filing.
