Dear Mr. Share:

The Remediation Division of the Bureau of Water Protection and Land Reuse ("the Department") has reviewed the Plan dated August 2009, titled "Final Perimeter Air Monitoring Plan, Non-Public Properties, Newhall Street Neighborhood, Hamden, CT". The Plan was prepared by MACTEC Engineering and Consulting, Inc. on behalf of Olin Corporation, and in conjunction with Consent Order SRD-128 and the Department's October 6, 2008 Conditional Approval of the Generic Remedial Action Plan.

The Plan describes the methods for monitoring ambient air quality during remedial construction of the non-public properties within the Newhall Street Neighborhood Site to ensure safe conditions are maintained for on-site workers and the surrounding community.

The above referenced Final Perimeter Air Monitoring Plan is hereby approved with the following condition: The Work Zone Perimeter Action Level for airborne particulate shall be 65 ug/m³. If it is determined that atmospheric conditions attributable to non-site related activities persistently interfere with particulate air monitoring results (i.e. false positive detections), the action level may be adjusted upward in consultation with the DEP and the Connecticut Department of Public Health.

Nothing in this approval shall affect the Commissioner's authority to institute any proceeding, or take any action to prevent or abate pollution, to recover costs and natural resource damages, and to impose penalties for violations of law. If at any time the Commissioner determines that the approved actions have not fully characterized the extent and degree of pollution or have not successfully abated or prevented pollution, the Commissioner may institute any proceeding, or take any action to require further investigation or further action to prevent or abate pollution. This approval relates only to pollution or contamination identified in the above referenced Plan.


